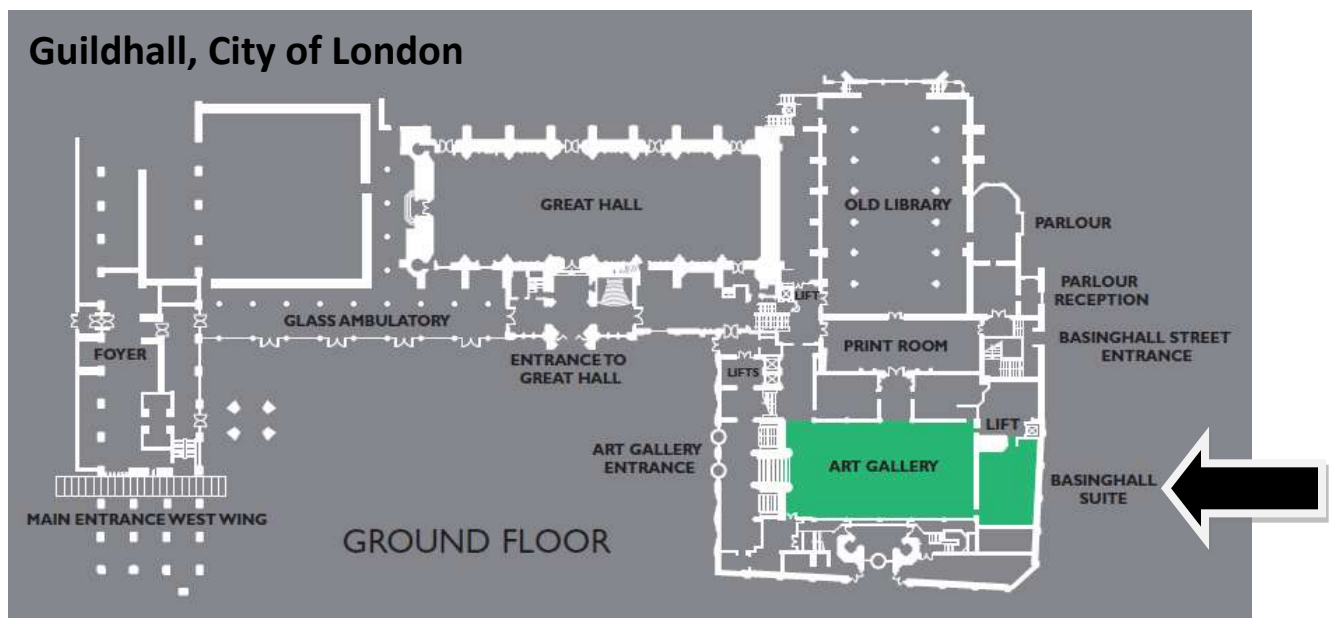
**PUBLIC INQUIRY INTO THE PROPOSED PARTIAL DEMOLITION
